

Harry Potter VR Experience Sweepstakes OFFICIAL RULES

3. **Eligibility.** The *Harry Potter VR Experience* Sweepstakes ("Sweepstakes") is open only to legal U.S. residents residing in one of the 50 United States or the District of Columbia, who are (a) at least 18 years of age (or the age of majority in their state of residence, whichever is older). To submit your entry, click the "Enter Now" button on the Website. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor or Administrator of such entry. Receipt of entry may be acknowledged but such acknowledgment does not constitute a representation by Sponsor or Administrator as to eligibility of entry.

Limit of one (1) entry per person, per email address during the Sweepstakes Entry Period regardless of the number of e-mail addresses or accounts a person may have.

Multiple entries in excess of this limitation or mass entry attempts may result in disqualification of all entries by such person or e-mail address. Entries must be manually key-stroked by the entrant; use of automated entry devices or programs, or entries by third parties, are prohibited.

- 6. Random Drawing/Odds.** Potential winners will be randomly selected on or about November 1, 2022 from among all eligible entries received during the Entry Period. Drawing will be conducted by Administrator, an independent organization whose decisions (along with those of Sponsor) are final and binding on all matters related to the Sweepstakes.

Odds of winning the Grand Prize depend upon the total number of eligible entries received during the Entry Period.

- 7. Winner Notification.** Potential winner will be notified by e-mail and/or phone (as applicable) on or about November 1, 2022. Failure to respond to the initial verification e-mail within three (3) business days after notification or return of e-mail notification as undeliverable after three (3) attempts may result in disqualification.
